NOTICE TO BIDDERS

Sealed bids will be received by the Gage County Clerk until April 3, 2024 at 9:15 a.m. for supplying materials required to construct corrugated metal pipes with steel headwalls and wingwalls and other related incidental work at five sites. The Bids will be presented to the Board for consideration on April 3, 2024 at their regularly scheduled meeting. The project sites are located; C-34(1245) – on East B Line between S. 176th Road and S. 190th Road; C-34(1247) – on S. 134th Road between East Oak Road and East Maple Road; C-34(1264) – on Sout 36th Road between East Osage Road and East Oak Road; C-34(1267) – on East Locust Road between South 120th Road and South 134th Road; C-34(1269) – on East Hickory Road between South 120th Road and South 134th Road, all in Gage County, Nebraska.

The project is referred to as "Gage County 2024 Culverts" and shall include all labor, materials, transportation, and equipment required to fabricate and deliver the materials to construct: C-34(1245) – twin 96" x 51' corrugated metal pipes on a 0 deg. skew, C-34(1247) – twin 84" x 47' corrugated metal pipes on a 30 deg. skew (rhb), C-34(1264) – triple 96" x 42' corrugated metal pipes on a 10 deg. skew (lhb), C-34(1267) – twin 84" x 40' corrugated metal pipes on a 0 deg. skew, C-34(1269) – triple 72" x 40' corrugated metal pipes on a 0 deg. skew, all with steel headwalls and wingwalls.

Copies of the Bid Documents and Specifications are open to public inspection at the office of the Gage County Highway Superintendent, 823 S. 8th Street, Beatrice, Nebraska 68310. All Bid Proposals must be submitted on the forms furnished with the Bid Documents.

The sealed bids may be mailed or delivered to the County Clerk of Gage County, County Courthouse, 612 Grant Street, PO Box 429, Beatrice, Nebraska 68310, and should be plainly marked as, "Materials Bid Proposal – Gage County 2024 Culverts".

Along with its Bid Proposal, each bidder shall submit an unconditional Bid Bond or Certified Check made payable to the County Treasurer of Gage County, Nebraska, in an amount equal to five (5) percent of the Bid Proposal. Also, each bidder is to include an estimated time of delivery for the materials with their Bid Proposal. The desired delivery date of the materials is twelve to fourteen weeks after the award of the contract. All materials shall be delivered to the respective project site.

Within ten (10) days following the award of the Contract, the successful bidder shall furnish a surety bond or bonds in an amount equal to or greater than the full amount of the contract. The surety and form of the bonds are subject to acceptance by the Gage County Board of Supervisors.

The Gage County Board of Supervisors reserves the right to reject any and all bids or to waive any irregularities in bids received. Award of the Contract will be in accordance with the County Purchasing Act's competitive bidding considerations as set forth in Neb.Rev.Stat. §§ 23-3110 to 23-3114. Gage County is an Equal Opportunity Employer.
